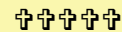

Dear Brothers and Sisters in Christ,



As we celebrate the Second Sunday of Easter which is also called the Divine Mercy Sunday, we are reminded that the nail marks on Jesus's hands and feet and the scar on his side are still bleeding everyday for our sins. Today's Gospel tells us that, after the resurrection, the Risen Christ appeared to his disciples and everyone was there except Thomas. The absence of Thomas did not happen by chance but rather it was God's providence. Also, the doubting Thomas' incidence does not have any negative impact upon our belief of Jesus' resurrection; but rather it strengthens and confirms our Lord's resurrection. When he was told by his fellowmen that Jesus Christ came back to life and appeared to them, he responded: "Unless I see the mark of the nails in his hands and put my finger into the nail marks and put my hand into his side, I will not believe." Thomas' demanding proof is providentially serving a two fold-purpose: proofs of the true resurrection of Jesus Christ and of His infinite mercy for humanity. When the Risen Christ appeared to His disciples again, at this time Thomas was with them, Jesus invited Thomas to put his finger into His nail marks and put his hand into His side; surprisingly Thomas did not do it but rather he just cried out from the depth of his heart: "My Lord and my God!" For Thomas, the evidence of the resurrection of Jesus was so overwhelming: Jesus was living, He was showing His crucified scars, and talking to him with the same caring voice and gentle way as it was the same Jesus before. For this reason, instead of touching and examining the scars of Jesus, Thomas cried out "My Lord and my God" which implied: "My Lord and my God, please forgive my obstinate heart and my unbelief". Indeed, the Risen Christ intended to keep the nail marks on his hands and feet and the scar on his side forever as signs of His Divine Mercy for all generations. Let us come to the Eucharistic Table to touch Jesus's nail marks and scars which are still bleeding everyday for love of us, to receive His Divine Mercy and be free from the guilt and condemnation of sin. "What a wondrous gift Oh my soul". Fr. Joe Pham.
