Dear Brothers and Sisters in Christ,



Today we celebrate the most profound precious Gifts of our faith, the Most Holy Body and Blood of Christ. Jesus did not abandon us or left us orphaned after His Ascension to the Father in heaven; but rather He was, is, and will always be with us until the end of time in the form of the Eucharist.

When Jesus said: “Whoever eats my flesh and drinks my blood will have life eternal” (John 6:54) He meant that whoever is united to me, receives me, or is in communion with me, will have eternal life with me in heaven. For this reason, the Church constantly reminds the faithful for the need to attend Mass regularly on Sunday. Indeed God is everywhere, we don’t have to go to church to pray; however, we cannot be intimately united, connected, and in communion with Jesus except by participating in the sacrifice of the Eucharist, the real Body and Blood of Christ.

At the Last Supper, Jesus took the bread and wine and directly said to His disciples: “Take and eat it..., take and drink....This is my body...This is the chalice of my blood...” by saying this Jesus meant it, He would not say this unless He meant it. Therefore, the sacrifice of the Mass is the ultimate source of salvation. It is the same sacrifice Jesus Christ offered on Calvary over 2000 years ago. During the Mass, it is being made present on the altar by the power of the Holy Spirit so that the faithful, from generation to generation, would be able to participate in the sacrifice of Jesus Christ for the sake of their salvation. In other words, the sacrifice of the Mass is for those who were not there when Jesus was crucified. We were not there when Jesus was crucified, so let us come every Sunday to be partakers of the Eucharist, the Body and Blood of Christ, the pledge of our eternal life which is only be found in the celebration of the Eucharist. *Fr. New Directives Regarding the Lifting of COVID-19 Restrictions



The following guidelines are issued for the Diocese of Camden:

LITURGICAL CELEBRATIONS – Beginning on Friday, May 28th, the faithful participating in Mass, who are vaccinated against COVID-19, are no longer required to wear masks. Those who are not yet vaccinated are encouraged to wear masks in accord with CDC guidelines. No one should be challenged in regard to this policy. All pews may be opened for seating, all social distancing requirements are lifted for celebrations that take place in the parish church(es). Beginning on Friday, June 4th, parishes may return to full capacity for seating. All ministries may return to full service - altar servers, lectors, ushers, greeters and Extraordinary Ministers of Holy Communion. Altar servers under the age of 12 should wear masks since they are not yet eligible for vaccination. Ushers may take up the offertory collection at the proper time and the procession to present the gifts of bread and wine is to be resumed. The invitation to share the Sign of Peace is likewise restored – it is not necessary that the faithful shake hands as there are other ways to offer the Sign of Peace or those present may choose to do so only with their immediate relatives. The distribution of Holy Communion is to be returned to its proper place within the Communion Rite, but the Precious Blood is not to be distributed to the faithful at this time. Parishes must continue to be vigilant about cleaning commonly touched surfaces.

Priests, deacons and Extraordinary Ministers of Communion should not only wash their hands before and after Mass, but should use hand sanitizer immediately before the distribution of Holy Communion.

STATEMENT OF THE NEW JERSEY BISHOPS *Reinstating the General Obligation to Attend Mass*

At this time, due to the observance of public safety protocols and the increase in the availability of vaccines, we have begun a return to some sense of normalcy in various sectors of our society.

Therefore, we the Catholic Bishops of New Jersey, are lifting the dispensation of the Sunday and Holy Days Mass obligation beginning on *Saturday, June 5, 2021, and Sunday, June 6, 2021*, Solemnity of the Most Holy Body and Blood of Christ. We welcome the Christian faithful to return to the regular participation in the Sunday Eucharist, the source and summit of our Catholic faith (cf. Code of Canon Law canon 1247 and Catechism of the Catholic Church, n. 2180).

This obligation does not apply to those who are ill; those who have reason to believe that they were recently exposed to the coronavirus or another serious or contagious illness; those who are confined to their home, a hospital, or nursing facility; or those with serious underlying health conditions. One should consult the local pastor if questions arise about the obligation to attend Mass (canon 87).

Finally, safety protocols (such as wearing masks, social distancing, etc.) and liturgical directives (communion in the hand, communion under one species, etc.) in each New Jersey Diocese remains in place until modified or revoked by the respective Diocesan Bishop.

Infant Jesus Parish will continue to live-stream the 4 PM Mass on Saturdays for the sick and homebound ONLY.

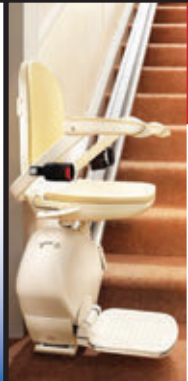
